EVENT TERMS

By ordering a ticket (or tickets) from this website, accepting an invitation to, or **otherwise attending VOGUE World (the “Event”)**, the Event attendee (**“you” or “your”**) **accepts and agrees to the terms and conditions set forth herein, including** our [Privacy Policy](#) (incorporated herein by reference), [Terms & Conditions](#) (incorporated herein by reference), and the Code of Conduct set forth further below.

Your ticket order/Event invitation (**“Ticket/Invitation”**) is an offer to purchase tickets to the Event organized by Condé Nast and hosted at the Theatre Royal Drury Lane (**“Venue”**) (**collectively, Condé Nast and Venue hereinafter referred to as “we”, “us”, or “our”**) and we and/or any authorized third party ticket booking **services (“Ticketing Services”) we use** retain the right, in our sole discretion, to refuse your order or rescind your Ticket/Invitation. If we accept your order or invite you to the Event, we and/or the applicable Ticketing Service will send you an email confirmation (or other form of written invitation/confirmation) of your completed order or invitation, for your information. You should print out a copy of the confirmation e-mail, or retain the written invitation/confirmation we provide, for your records. Tickets/Invitations are non-refundable and no exchanges are permitted.

The Ticket(s)/Invitation(s) are non-transferable and for personal use only, and shall not be sold, assigned or otherwise transferred for any reason. You hereby represent and warrant that (i) any Ticket(s)/Invitation(s) you purchase or receive are for personal use only and will not be sold, assigned or transferred, or used as part of any form of business or commercial activity; and (ii) you will not (a) resell or offer for resale any Ticket(s)/Invitation(s) (whether at a premium or otherwise)

and/or (b) use the Ticket(s)/Invitation(s) for advertising or promotions (including prize draws, competitions, contests and/or sweepstakes) or for any other trade purposes.

We reserve the right, in our sole discretion, to refuse admission to the Event to any **person for any reason, including, without limitation, a person's breach of these** terms and conditions and code of conduct, or our determination, in our sole discretion, that a person may be disruptive or otherwise objectionable.

We reserve the right, in our sole discretion, whether for safety reasons, weather, business considerations, or otherwise, and with or without prior notice, to cancel or reschedule the Event. In the event of such cancellation, our liability to you shall be limited to a refund of the price paid by you for your ticket purchase (if applicable); in no event will we or any third party be responsible for travel, hotel, or other costs.

Our total liability for any and all claims arising out of or in connection with your purchase of ticket(s) through this website shall be limited to the price paid by you to us for those tickets (if applicable) and you hereby agree that the maximum remedy available to you on any claim against us shall be a refund of the cost of your ticket purchase (if applicable). IN NO EVENT (INCLUDING, BUT NOT LIMITED TO, CANCELLATION OF THE EVENT FOR ANY OR NO REASON) WILL WE BE LIABLE TO YOU FOR ANY INDIRECT, CONSEQUENTIAL, EXEMPLARY, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES, FOR LOST PROFITS, OR FOR ANY TRAVEL, TRAVEL-RELATED OR HOTEL EXPENSES, WHETHER BASED UPON BREACH OF CONTRACT, BREACH OF WARRANTY, TORT, OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGE.

Condé Nast cannot guarantee to cater to special dietary requirements, lifestyle choices (vegan, etc.) or those with allergies or food intolerances. Attendees will be responsible for monitoring the ingredients of dishes. Condé Nast is not responsible for any reactions due to food allergies.

We assume no responsibility for lost or destroyed Ticket(s)/Invitation(s). Unless otherwise expressly permitted by Condé Nast, Ticket(s)/Invitation(s) in their entirety and photo identification must be presented in good condition for entry into the Event. If the Ticket/Invitation holder leaves the Event for any reason, the same Ticket/Invitation may not be used to re-enter the Event.

The use of photographic and recording equipment at the Event is strictly prohibited. However, the Event may be filmed and photographed. By attending the Event, you are consenting to the use of photographs and recordings of you (including your voice, image or likeness), in any and all media, including print, online and television, as well as editorial, promotional or advertising materials for us and/or our affiliates, sponsors and designees. Notwithstanding the foregoing, attending the Event does not guarantee that images of you will be included in any such materials, including in any Vogue articles or on our social media channels.

We shall not be responsible for any damage or loss to personal property brought to the Event.

Some areas of the Event venue may be restricted to certain Ticket holders. Condé Nast reserves the right to refuse entry to particular areas of the Venue to attendees. You agree to promptly comply with all instructions provided by Condé Nast staff or third party staff at the Event and to follow signage of the Venue.

Some events are limited to persons at least 18 years of age. If the Event is listed as 18 and over admittance only, then no one under the age of 18, including, but not limited to children in strollers accompanied by adults, may attend the Event. By purchasing a ticket for an over 18 event, you represent that you are at least 18 years of age and agree to provide us a valid government-issued photo **identification (e.g., driver's license or passport) upon our request** therefore. You acknowledge that the consumption of alcoholic beverages by individuals under the age of 18 is unlawful.

Condé Nast endeavors to provide a safe and enjoyable experience for all Event attendees, staff and vendors. To that end, we expect all Event attendees, staff and vendors to adhere to the below Code of Conduct. If, in our sole discretion, we determine that you have violated this Code of Conduct at any time, we reserve the right to (i) expel you from the Event and/or (ii) prohibit you from attending any future Condé Nast events. If you are expelled from an Event or prohibited from attending future Condé Nast events due to a breach of this Code of Conduct, you shall not be entitled to a refund of any ticket purchase prices.

Code of Conduct

- All Event participants are expected to behave in an appropriate manner. Condé Nast will not tolerate harassment in any form, including but not limited to the following:
 - harassment or offensive comments based on sex, gender identity or expression, sexual orientation, disability, physical appearance, body size, weight, race, color, age, religion, national origin, ancestry or any other status protected by laws in which the Event is being held, including epithets and slurs
 - sexual advances or propositions
 - any type of sexual activity or contact
 - any suggestion, direct or implied, that submission to or rejection of sexual advances is required or will have any impact on the rights and opportunities afforded to another person
 - display of pornographic or obscene material
 - physical threats or assaults.
- We do not tolerate any inappropriate touching or other unwanted physical contact or inappropriate levels of non-physical contact.
- Be polite, considerate and respectful to all Event attendees, staff and vendors. We do not tolerate bullying or disruptive behavior of any kind.
- We do not permit any weapons, drugs or any illegal substances on the Event premises.

- You are not permitted to contact any Condé Nast staff or vendors outside of the Event forum or their professional contact channels without such staff **member's or vendor's express permission. For the avoidance of doubt, you** are not allowed to contact Condé Nast staff or vendors on their personal social media channels.
- If alcoholic beverages are offered or served at the Event, you agree (i) to fully comply with the rules established by us from time to time in connection with the service and consumption of such beverages; (ii) not to consume such beverages in an irresponsible or excessive manner; (iii) not to consume such beverages at all if such consumption by you is unlawful or potentially dangerous to you or others; and (iv) not to serve or furnish alcohol to persons under 18 years of age.
